



**MIX 100 "BEACH PARTY AT THE LOUD HOUSE
WITH THE COLORADO MAMMOTH"
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

THE CONTEST

- a. The MIX 100 ("Station") "Beach Party at the Loud House with the Colorado Mammoth" contest (the "Contest") will begin on Tuesday, January 4, 2020 and end on Friday, January 24, 2020. The contest will be played Monday – Friday between the hours of 3:00pm MT and 6:00pm MT. (Contest Period) To play this contest listen for the cue to call in during contest hours. Designated caller will win a pair of tickets to see the Colorado Mammoth vs. Buffalo Bandits game on Saturday, January 25, 2020 at 7:30pm, two Mammoth branded beach shirts and QUALIFY for the opportunity to compete for the Grand Prize in a contest during the under 10 time-out in the 2nd quarter. Two contestants will be chosen out of all eligible qualifiers who qualified during the contest period to compete in the contest. The contest will consist of lining up the two contestants on either the same side of the arena playing surface or the opposite sides. This will be determined by the Mammoth host. The contestants will be blindfold and an inflatable palm tree will be placed randomly on the arena playing surface floor. The first contestant to touch the palm tree within the one minute time limit will win the Grand Prize. In the event neither contestant touches the Palm Tree in the one minute time limit, the contest will be extended until one of the contestants touches the Palm Tree. MUST BE 21 AND OVER TO PLAY THE CONTEST FOR THE GRAND PRIZE.
- b. **GRAND PRIZE:** A 2-night stay at the Welk Resort in San Diego, California. Grand Prize includes roundtrip coach airfare from Denver, Colorado to San Diego, California, and a two night stay in a small one bedroom. This two-night stay is based on availability. Peak season, holidays, and black-out dates may apply. The decisions of the Colorado Mammoth in all matters relating to the Contest are final. Grand Prize is non-transferable.
- c. Station is not responsible for charges entrants may incur that result from wireless phone or Internet transmissions. The Station is not responsible for service outages, delays, equipment malfunctions and any other technological difficulties that may prevent an entrant from entering the Contest.
- d. Entries will not be returned and receipt of entries may not be acknowledged. Proof of entry submission will not be deemed to be proof of receipt of entry by Sponsor or Station. Each entry must be an original work created by entrant, and by entering the Contest, each entrant agrees that such is the case.
- e. The potential winner may be required to prove eligibility, including, without limitation, proof of age, residence and identity, which may include submitting a copy of a driver's license, passport or similar government issued identification within two (2) business days of being notified of being a potential winner.

ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all KIMN-MIX 100 listeners who are 21 years of age or older and who are legal residents of the state of Colorado. Employees of KIMN (the "Station"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Denver metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. This Contest is subject to all applicable federal, state and local laws and regulations.
- b. Contestants may only win twice per household address every CALENDAR regarding daily giveaways such as concert tickets, gift cards, movie passes, etc. Contestants can only win once per month for a MAJOR STATION contest unless otherwise noted in the Rules.
- c. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.
- d. Decisions of the Station management with respect to the Contest are final.
- e. All prizes or prize certificates may be picked up at East Reception at the Pepsi Center located at 1000 Chopper Circle, Denver, CO 80204. Prize pick-up is Monday – Friday between 9:00 – 5:00. **The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. The 30-day rule does not apply to prizes that are awarded in the form of a Company check.** In the event a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- f. There is no substitution, transfer, or cash equivalent for prizes, except that Station may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

WINNER SELECTION AND NOTIFICATION

- a. Grand Prize winner will be drawn by Station at random from all eligible qualifiers.

CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. All winners will be required to sign an IRS Form W-9 or the equivalent if they win \$600 or more or their prize is valued at \$600 or more. Failure to provide an accurate and complete Social Security Number, if required, is a violation of federal law and will result in forfeiture of prize.
- b. By participating in the Contest, each winner agrees to have the winner's name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.
- d. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. The Station reserves the right to make changes in the rules of the Contest, including the substitution of a prize or equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event is delayed, rescheduled, postponed, cancelled or has a change of venue, the Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- f. Failure to comply with the Contest rules may result in a contestant's disqualification, solely at the discretion of the Station.
- g. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
